- b) To seek continued improvements to, and the maintenance to a high standard of, those harbour facilities available to St. Helier boat owners.
- c) To ensure a fair and open system of berth and mooring allocation.
- d) To maintain close liaison with the Harbour Authorities and with other Harbour Users.

General Data Protection Regulations (GDPR)

To meet the requirements of the EU-wide GDPR, the States have passed the Data Protection (Jersey) Law 2018, which takes effect from 25th May 2018. The Law provides additional controls on organisations who hold personal data and further rights for individuals whose data are held.

The Association is the controller of the data you provided on your membership application form and any further personal information you have sent or may send to us in future, which we accept as clear affirmative action for the legal basis allowing us to hold the data. Your data comprises some or all of the following:

1. Your name, address, phone number & Email address;
2. Your bank a/c details, which are passed to your bank to set up your subscription standing order.
3. Information about your boat, its location & your boating interests.

We do not hold data from any other sources, except for statements from our bank, which include subscription standing order payments.

Your data are held to facilitate the management your subscriptions and to provide you with Association and boating related information from time to time.

Your data are stored in a password-protected & backed-up spreadsheet or database, or in secure paper format by the Treasurer/Membership Secretary and may be shared with officers, members of the Association committee & our Independent Examiner, from time to time. Your data are not shared with any other third parties.

Your data will be held during the period of your membership & for a reasonable time thereafter, to allow for the cancellation and/or refunding of your subscription & will then be deleted.

You have the right request details of your data that we hold by writing to the Treasurer/Membership Secretary.

You also have the right to withdraw your consent for any of your data being held, however this may require the termination of your membership.

You also have the right to complain to the Data Protection Authority if a problem concerning your data cannot be resolved to your satisfaction.
